Background

The Community Infrastructure Levy (CIL) is a new power which enables a charge to be levied on new development in order to fund infrastructure that is needed to support development.

In London CIL can be charged by both the Mayor of London and local authorities.

On 1 April 2012, the Mayor of London introduced a London-wide CIL which will be used to collect contributions to assist with the funding of Crossrail and on 1 July 2013 Brent introduced a local CIL which is charged alongside the Mayor's CIL.

To ensure that the levy is open and transparent, Brent is required to prepare a short report on the levy to be published a report on our website by 31 December each year, for the previous financial year. This includes the details of the Neighbourhood Fund.
