**Notice is hereby given, in accordance with Regulation 22(3) of the Town and Country Planning (Local Planning) (England) Regulations 2012, that the London Borough of Brent submitted the Brent Local Plan 2019-2041 to the Secretary of State for Housing Communities and Local Government on Tuesday 17<sup>th</sup> March 2020 for independent examination.**

**Examination process:**

The examination of the Brent Local Plan therefore begins on Tuesday, 17<sup>th</sup> March 2020. Provided that the Planning Inspectorate considers that the council has met the statutory and relevant legislative/procedural requirements on submission, the Local Plan will be subjected to an independent examination to be conducted by the Planning Inspectorate. The appointed Inspector will examine if the Brent Local Plan meets the tests of soundness defined in the National Planning Policy Framework. The process will involve hearing sessions where those invited by the appointed Planning Inspector will have the opportunity to respond to matters raised. Once confirmed, all details relating to the examination process will be announced and published on the council's examination website. This is a continuous process running from the date of submission through to the receipt of the appointed Planning Inspector's Report.
