The draft Brent Local Plan is currently going through the examination hearing process. Natural England commented on the HRA (part of the Integrated Impact Assessment) of the draft local plan at Preferred Options stage (Regulation 18), commenting that "Natural England agree with the conclusion that the emerging Brent Local Plan is not likely to have significant effects on the qualifying features and integrity of the identified European sites". Natural England then commented on the Local Plan at Publication Stage (Regulation 19), but did not provide any further comments specifically on the HRA.

The Planning Inspectors, as part of the examination process, have requested that the council confirm with yourselves that you are still happy with the HRA and the conclusions of the HRA? The submission version of the HRA can be found here, from page 503 onwards:
