I would like to lodge my objection as a resident who will be directly affected by this development. This massive project in a small former village, I and my neighbours will see this imposing ugly sight from my house and affecting house prices negatively.

Several other issues will be obvious and detrimental around Alperton station.

1) Changing the character of the area. The Bridgewater Road proposal was in an area where the majority of housing is two storey homes.
